### Happy Friday!

The House was not in session this week, but I was still working hard to advance the interests of the Fifth District. From finding solutions to improve Arizona's higher education to holding the officials involved with the unprecedented FBI raid at President Trump's Mar-a-Lago residence accountable, I hope you'll read below to learn about the important happenings from the week:

### Holding Officials Involved with the FBI Raid at Mar-a-Lago Accountable

Last week, Joe Biden's FBI raided Mar-a-Lago—President Trump's private residence. The FBI seized around 20 boxes of documents. The raid is considered unprecedented and the true reason or support for the raid remains unclear.

But what is clear is that the Biden Administration weaponized its law enforcement resources to publicly target a political opponent and I will not let it go unchecked.

This week, I co-signed House Judiciary Committee letters addressed to Assistant to the President and White House Chief of Staff Ronald Klain, FBI Director Christopher Wray, and Attorney General Merrick Garland demanding documents, communications, and more information relating or referring to the execution of a search warrant at Mar-a-Lago.

Our law enforcement apparatus should serve the American public—not special interests. My colleagues and I will ensure that we hold these figures accountable and help restore trust in these institutions.
